## **2022 Fisherman's Point Campground Seasonal Sites Drawing**

1. Comply with all Campground regulations as stated on the Campground Rules. Violation of these rules or any of the rules below will be cause for cancellation of this agreement.
2. The total payment for the site will be \$2,600 with a deposit of \$1,000 (lakeshore) or \$2,100 with a deposit of \$1,000 (non-lakeshore) due within 10 days of the drawing and the balance due by April 29, 2022. Refunds will only be considered in extreme circumstances at the discretion of the City Administrator.
3. The sites will be available on April 29, 2021 until October 31, 2021 at which time all personal property must be removed and the site left in a clean condition. Tenants must pay \$12.50/day non-seasonal rate for any stay past or prior to these dates. In the months of September and October the availability of water, docks, rest rooms, and other amenities is weather dependent and subject to closure/removal at any time.
4. Seasonal campers will do their own grass cutting and campsite cleanup. This must be done on a regular basis.
5. A \$100.00 pet deposit for each pet, payable by check, is due prior to April 29, 2022. If complaints are received and it is discovered the camper has a pet which was not disclosed, the seasonal agreement will be considered cancelled. The pet deposit will not be refunded if there are numerous complaints regarding the pet, if pet waste is found in the campsite after season, or if the pet causes damage to the campsite or campground.
6. All camping units except tents must be wheeled vehicles. Seasonal campers are not permitted to make any site improvements including moving in of storage units, docks, landscaping, etc. A seasonal camper is permitted to have one camping tent and one screen house at no additional cost. Two campers are not permissible under any circumstances.
7. Only one form may be submitted per household/camping unit.
8. A drawing will be held at 10:00 a.m. on Friday, September 24, 2021 at Hoyt Lakes Municipal building in the Council Chambers. **All seasonal site applications must be submitted to the Hoyt Lakes City Clerk's Office, 206 Kennedy Memorial Drive, Hoyt Lakes MN 55750 by 4:00 pm on Friday, September 17, 2021 to be considered for the drawing.**
